

ICS -400 Advanced ICS for Complex Incidents

Course Goal

This course provides training on and resources for personnel who require advanced application of the Incident Command System (ICS). This course expands upon information covered in the ICS 100 through ICS 300 courses, which are prerequisites for ICS 400.

Course Description

This course provides training for personnel who require advanced application of the Incident Command System (ICS).

ICS 400 is intended for an audience of experienced responders and other senior emergency management personnel. The purpose of this course is to expose students to the concepts of utilizing area command in major and complex incidents.

ICS-400 expands upon information covered in IS 100, IS 200, ICS 300, IS 700, & IS 800 courses, prerequisites for the ICS 400 course.

This training is for senior personnel assigned to staff or support EOC functions. The audience may include personnel from various agencies and disciplines, such as Fire and Rescue, EMS, law enforcement, emergency management, regional/city/county/tribal emergency operations, public safety and security roles, public health, and other EOC staff functions.

The following courses are required: (most current 0300 and 0400 must be 2019 or later):

- IS 100.c: Introduction to the Incident Command System
- IS 200.c: Basic Incident Command System for Initial Response
- ICS-300 ICS for Expanding Incidents (2019 or later)
- IS 700.b: An Introduction to the National Incident Management System (NIMS)
- IS 800.d: National Response Framework, An Introduction
